Pre-SIEF (Substance Information Exchange Forum)

SIEFs are managed by industry, not by ECHA. Please contact your industry association for information on available tools for managing the SIEFs.

The REACH-IT module will allow a pre-registrant to see who else has pre-registered the same substance. The information is displayed on a **substance specific pre-SIEF page**. This page provides the following information:

General information:

- substance identification
- identification of similar substances, if applicable (substances which may facilitate the risk assessment of the substance)

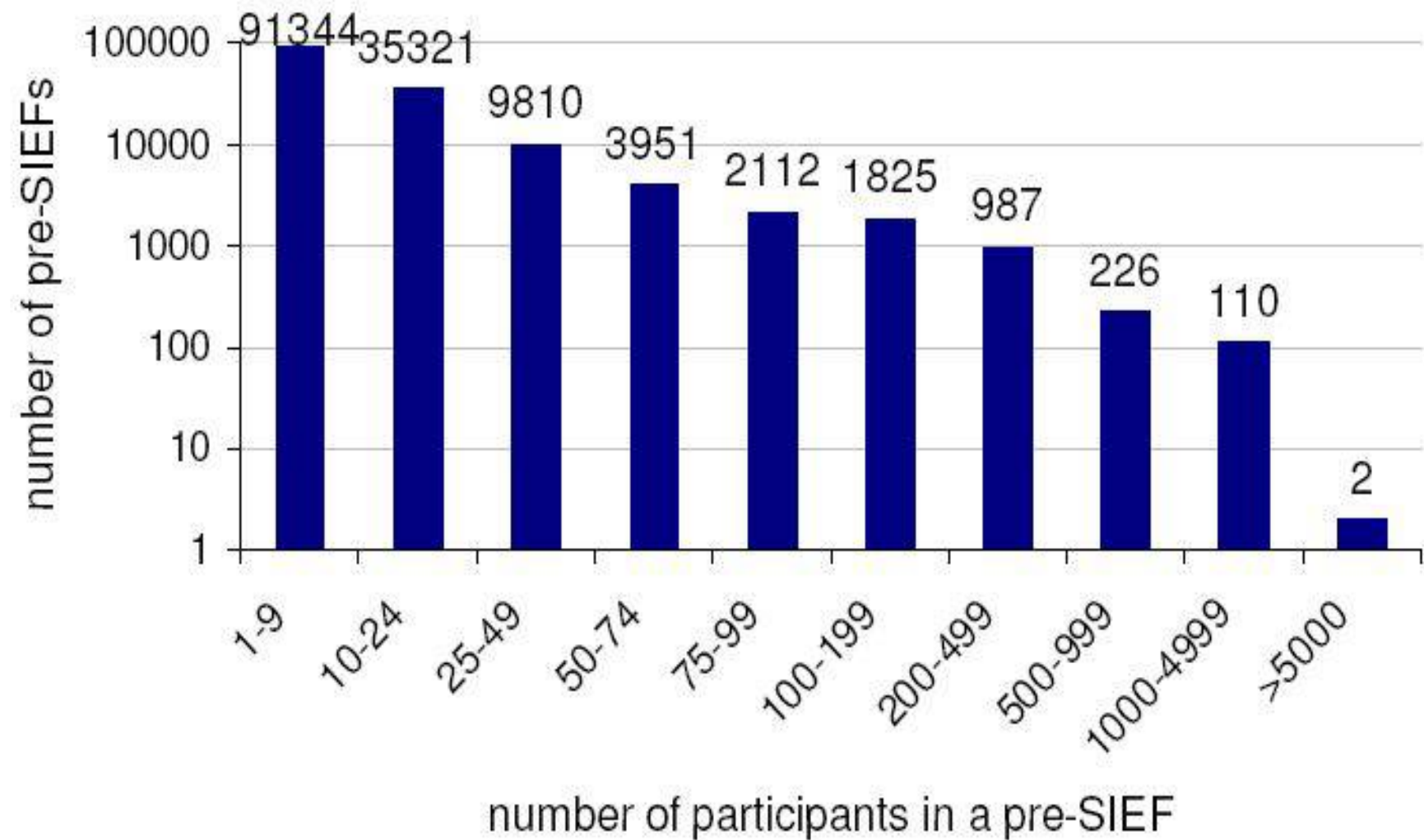
Company specific information:

- contact information as specified during pre-registration (the third party representative or the company contact person or the company's general contact details)
- the envisaged registration deadline
- the pre-registration number
- the remarks for the other pre-SIEF participants

Companies who have pre-registered a substance will automatically become listed on the pre-SIEF page of this substance.

To initiate discussions after pre-registration, a pre-registrant can volunteer on the pre-SIEF page to become **SIEF formation facilitator**.
